- 6.2 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents Failure to furnish all information or documentation required by the Bidding Documents may result in the rejection of the bid.

7. **Clarification of Bidding Documents** 7.1 A prospective Bidder requiring any clarification of the Tender Document including the restrictiveness of specifications shall Contact the Purchaser in writing at the Purchaser's address specified in the Bidding document. The Purchaser will respond in writing to any request for clarification, provided that such request is received prior to the deadline for submission of Tender. The Purchaser shall forward copies of its response to all those who have purchased the Bidding document, including a description of the inquiry but without identifying its source. Bid Documents as a result of a clarification, should the purchaser deemed it necessary to amend it shall do so following the procedure under ITB Clause 8.

8. **Amendment of Bidding Documents** 8.1 At any time prior to the deadline for submission of Bid, the Purchaser may amend the Bidding Documents by issuing an addendum.
- Any addendum issued shall be part of the Bidding Documents and shall be communicated in writing to all who have purchased the Bidding Documents.
- To give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, the Purchaser may, at its discretion, extend the deadline for the submission of bids, pursuant to ITB Sub-Clauses 23.2.

### **Preparation of Bids**

9. **Cost of Bidding** 9.1 The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Purchaser shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
10. **Language of Bid** 10.1 The Bid, as well as all correspondence and documents relating to the Bid (including supporting documents and printed literature) exchanged by the Bidder and the Purchaser, shall be written in English language.
11. **Documents Comprising the Bid** 11.1 The Bid shall comprise the following.
- a) Bid Submission Form and the applicable Price Schedules, in accordance with ITB Clauses 12, 14 and 15;
  - b) Bid Security, in accordance with ITB Clause 20.
  - c) Documentary evidence in accordance with ITB Clauses 18 AND 29, that the Goods and Related Services conform to the Bid Documents;
  - d) Documentary evidence in accordance with ITB Clause 18 establishing the Bidder's qualifications to perform the contract if its bid is accepted; and
  - e) Any other document required in the Bid.
12. **Bid Submission from And Price Schedules** 12.1 The Bidder shall submit the Bid Submission Form using the form furnished in Section IV Bid Forms. This form must be



Completed without any alterations to its format, and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested.

The Bid Security may be forfeited executed:

- a) If a Bidder withdraws its bid during the period of bid validity specified by the Bidder on the Bid Submission Form, except as provided in ITB Sub-Clause 19.2; or
- b) If a Bidder does not agreeing to correction of arithmetical errors in pursuant to ITB Sub-Clause 30.3
- c) If the successful Bidder fails to:
  - i. Sign the Contract in accordance with ITB Clause 42,
  - ii. Furnish a Performance Security in accordance with ITB Clause 43.

21. **Format and  
Signing of Bid**

- 21.1 The Bidder shall prepare one original of the documents comprising the bid as described in ITB Clause II and clearly mark it as "ORIGINAL" In addition, the Bidder shall submit a copy of the bid and clearly mark it as "COPY". In the event of any discrepancy between the original and the copy, the original shall prevail.
- 21.2 The original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder.
- 21.3 Any interlineations, erasures or overwriting shall be valid only if they are signed or initiated by the person signing the Bid.

- 26.2 First, envelopes marked "WITHDRAWAL" shall be opened and read out and the envelope with the corresponding bid may be opened at the discretion of the Purchaser. No bid withdrawal shall be permitted unless the corresponding withdrawal notice contains a valid authorization to request the withdrawal and is read out at bid opening. Envelopes marked "MODIFICATION" shall be opened and read out with the corresponding Bid. No Bid modification shall be permitted unless the corresponding modification notice contains a valid authorization to request the modification and is read out at Bid opening. Only envelopes that are opened and read out at Bid opening shall be considered further.
- 26.3 All other envelopes shall be opened one at a time, reading out; the name of the Bidder and whether there is a modification; the Bid Prices; including any discounts and alternative offers; the presence of a Bid Security if required; and any other details as the Purchaser may consider appropriate. Only discounts and alternative offers read out at Bid opening shall be considered for evaluation. No Bid shall be rejected at Bid opening except for late bids in accordance with ITB Sub –Clause 24.1.
